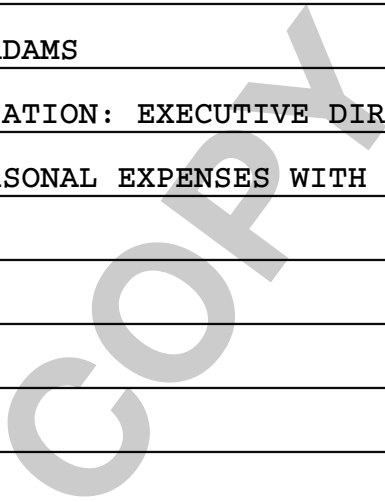

THE ST. LOUIS AREA DIAPER BANK WAS FOUNDED IN 2014 TO FILL A GAP IN ST. LOUIS' BASIC NEEDS NONPROFIT ECOSYSTEM. FOOD PANTRIES, LOCAL SAFETY-NET ORGANIZATIONS, AND GOVERNMENT ASSISTANCE PROGRAMS PROVIDED LITTLE OR NO SUPPORT FOR DIAPERS - A CRITICAL NEED FOR ANY FAMILY WITH YOUNG CHILDREN. THE ST. LOUIS AREA DIAPER BANK PROVIDES DIAPERS TO LOW-INCOME FAMILIES IN THE ST. LOUIS REGION BY COLLECTING DIAPERS THROUGH DIAPER DRIVES OR PURCHASING THEM AT A DISCOUNT THROUGH OUR MEMBERSHIP IN THE NATIONAL DIAPER BANK NETWORK; PACKAGING DIAPERS AND RELATED PRODUCTS AT OUR WAREHOUSE; AND DISTRIBUTING DIAPERS THROUGH OUR NETWORK OF 57+ COMMUNITY PARTNERS ACROSS 70+ LOCATIONS IN ST. LOUIS CITY, ST. LOUIS COUNTY, JEFFERSON COUNTY, AND EAST ST. LOUIS. FAMILIES WHO NEED DIAPERS USUALLY NEED OTHER SERVICES AS WELL, SUCH AS CASE MANAGEMENT, FOOD, MEDICAL ATTENTION, AND JOB TRAINING - TO NAME A FEW. THIS MODEL ALLOWS OUR DIAPERS TO ACT AS A "GATEWAY RESOURCE", CONNECTING FAMILIES WITH THE PARTNER AGENCIES WHO PROVIDE BOTH DIAPERS AND THESE OTHER NEEDED SERVICES. THE ST. LOUIS AREA DIAPER BANK DISTRIBUTED OVER 3 MILLION DIAPERS IN 2020 TO 55,000 CHILDREN AND FAMILIES. IN 2020, THE ST. LOUIS AREA DIAPER BANK EXPANDED TO ADDRESS ANOTHER PRESSING NEED: PERIOD POVERTY. LIKE THE DIAPER PROGRAM, THE ALLIANCE FOR PERIOD PROVIDES PERIOD PRODUCTS TO GIRLS, WOMEN, AND MENSTRUATING INDIVIDUALS THROUGH A NETWORK OF COMMUNITY PARTNERS IN THE ST. LOUIS AREA. THE PROGRAM HAS 8 COMMUNITY PARTNERS, DISTRIBUTED OVER 400,000 PERIOD SUPPLIES TO 10,000 INDIVIDUALS IN ITS INTRODUCTORY YEAR.

CONSTANT CRYING FROM BABIES WHO ARE LEFT IN DIRTY DIAPERS IS FRUSTRATING FOR PARENTS AND PUTS CHILDREN AT A DRAMATICALLY INCREASED RISK OF CHILD ABUSE.
